FUFA

APPLICATION PROCEDURE FOR INTERMEDIARIES

FIFA in its 64th congress abolished football agents and replaced it with "INTERMEDIARIES" through the FIFA regulations on working with intermediaries. FIFA required all its member association to regulate and register anyone who intends to carry out intermediary activities as defined in both the FIFA and FUFA regulations on working with Intermediaries.

Therefore FUFA call all Individuals and companies wishing to conduct any "Intermediary Activity" as defined under the FUFA Regulations on Working with Intermediaries (including entering into a Representation Contract with a client) to register with FUFA by 30th June 2016 5:00 pm (east African time).

A. APPLICATION PROCEDURE.

- 1) The applicant will pick an application form from FUFA or down load from our website. The application form is only complete if the test of good character is attached.
- 2) The filled form will be submitted to FUFA together with proof of payment of application fees of \$ 100 (one hundred US Dollars) or its equivalent.
- 3) Applicants will be required to attend a one day seminar at FUFA house Mengo on the 20^{th} May 2015 from 8:00 am.
- 4) FUFA will review and verify the applications and contact only the successful applicants
- 5) The successful applicants will be issued with an intermediary license upon proof of payment of \$ 2000 (two thousand US Dollar) or its equivalent.

B. Registering a company as an Intermediary

Individuals intending to register a company as an Intermediary will need to register themselves as Intermediaries first to access the option to register the company as an intermediary. It is not a mandatory requirement for individuals registered as Intermediaries to register the company they are operating through as an Intermediary as well.

C. Waiver for current licensed agents.

This initial registration fee will be waived for those individuals who were FUFA Licensed Agents as at 31st of March 2016). This registration will need to be renewed and maintained in order to continue conducting Intermediary Activity and FUFA will charge \$ 500 (US Dollar five hundred) for every annual renewal.

D. Working with Minors

Applicants wishing to work with Minors (whether that be representing Minors or representing Clubs in respect of Minors) will need a special approval from FUFA and subject to all the

E. Test of Good Character and Reputation

Individuals are required to declare they comply with the criteria of the Test of Good Character for Intermediaries before registration, and Intermediaries must confirm they continue to meet those criteria every time they carry out Intermediary activity in relation to a Transaction. The test also contains provisions for Intermediaries applying to work with or in relation to Minors. Test of Good Character for Intermediaries document is attached to the application form which can be accessed from our web site.
