RE: CLUB LICENSING PROGRAMME 2020/2021

One of the key focus areas in our strategic plan is to improve Football Competitions particularly professionalization of Club Football in Uganda.

Having released comprehensive Club Licensing Regulations FUFA will now embark on the Clubs Pro Agenda to facilitate clubs to re-engineer their sporting and business processes and deliver short, medium and long term planning.

The training will also prepare the clubs for the upcoming club licensing exercise that will assess and grade clubs beyond sporting merit to be able to participate in various levels of football competitions in the season 2020/2021.


