REF: REGIONAL FOOTBALL ASSOCIATIONS, PROVINCE/ZONAL EXECUTIVE COMMITTEE ELECTIONS, AND BY ELECTIONS FOR VACANT FUFA DELEGATE POSITIONS

Dear Sir or Madam

In accordance with Art 10 par 1 of the FUFA Electoral Code, the FUFA EC hereby issues a schedule of electoral activities for the upcoming Regional Football Associations, Province/Zonal Executive Committee elections, and By Elections for vacant FUFA delegate positions.

FUFA Electoral guiding documents

The following documents: FUFA Statutes, FUFA Electoral Code and FUFA Electoral Guidelines, FUFA Circular No 1208 and FUFA EC Circulars shall govern the electoral process of all Regional Football Associations (RFA), Province/Zonal Executive Committee elections, and By Elections to replace FUFA delegates elected to the FUFA Executive Committee. Election of the Executive Committee of RFA

In addition to the electoral guiding documents above, FUFA EC hereby highlights the specific guidelines for the election of RFA Executive Committee.

In reference to Article 15 of the FUFA Electoral guidelines, The Elective Assembly for these elections will compose of;

- a) 3 DFA Delegates from each DFA comprising the RFA
- b) 1 FUFA Registered Club Official from each of the 3rd Division League Clubs
- c) 1 FUFA Registered Club Official from each of the Regional Women Football League Clubs
- d) The Elected Representative of the Referees to the Regional Football Association Assembly
- e) The Elected Representative of the Players to the Regional Football Association Assembly
- f) The Elected Representative of the Coaches to the Regional Football Association Assembly
- g) The Elected Representative of Women Football to the Regional Football Association Assembly

- h) The Elected Representative of Youth Football to the Regional Football Association Assembly
- i) The Elected Representative of Schools Football to the Regional Football Association Assembly

In **accordance** with Article 9 (5) of the FUFA Electoral Code, for any person to be eligible for the candidature of the Chairman of a Member of FUFA, he/she shall have served as a registered football official at a member of FUFA or a member of a member of FUFA for the last consecutive two (2) years before the elections and must have obtained at least a FAMACO II Certification.

The prospective Candidate shall pick or download nomination forms and submit the same along with a list of proposed executive committee members, each bearing their respective signatures.

Election of Executive Committee of the Province/Zonal Football Associations

The eligibility criteria for candidates and voters to participate in the Executive Committee elections of the Province/Zonal Football Associations shall be in accordance with FUFA Circular No 1208 available on the FUFA website www.fufa.co.ug

For purposes of clarity, Province/Zonal Executive Elections shall only be conducted in the provinces listed by FUFA Circular No 1208.

The prospective Candidate for the Executive Committee of the Province/Zonal Football Association shall pick or download nomination forms and submit the same along with a list of proposed executive committee members, each bearing their respective signatures.

All eligible candidates and voters intending to take part in the aforementioned elections are advised to verify and update their particulars in the register starting 11th November 2025.

By Elections to replace Delegates elected to the FUFA Executive Committee

Pursuant to Article 23(12) of the FUFA Statutes, delegates who were elected to the FUFA Executive Committee shall cease to serve as delegates, and their positions are to be subsequently replaced.

In view of the above, the FUFA EC issues Annex-1, listing vacant positions to be filled by individuals who meet the requirements of the FUFA Statutes, Electoral Code, and Electoral Guidelines.

Nomination process for all the above-mentioned positions

Nomination of candidates for all the above-mentioned positions shall be in accordance with the FUFA Electoral Guidelines and FUFA EC Circular No 1208, for purposes of clarity, all persons eligible to participate in the above-mentioned elections, shall download nomination forms from the FUFA website www.fufa.co.ug.

Only candidates for the position of Province/Zonal Executive Committee who unable to download forms from the FUFA website or with internet accessibility challenges shall pick physical nomination forms from the FUFA EC electoral officials at the FUFA EC head office or RFA Headquarters, or any other venue as shall be communicated by the FUFA EC.

For purposes of clarity, duly completed nomination forms shall only be accepted by the FUFA EC electoral official if returned by the intending candidate in person or via FUFA Electoral Committee email ec.fufa@gmail.com

The issuance and receipt of completed nomination forms, as well as the declaration of candidates and polling dates, will occur on the dates specified in **Annex 3**.
